Construction All Risks Insurance

Conditions:	Cover provided by this insurance is subject to the terms, conditions and exclusions of the Policy.
Territorial Limits:	Great Britain, Northern Ireland, Republic of Ireland, the Isle of Man or the Channel Islands but including: a) Employees on business trips outside of these territories in a non-manual capacity b) manual and non-manual Employees temporarily employed outside these territories provided that the contract of employment was entered into in the aforesaid countries

Limit of Liability:	GBP 20,000,000 any one Occurrence but GBP 20,000,000 any one Occurrence and in the aggregate for the Period in respect of Products Liability and Pollution or Contamination Liability.
Conditions:	Cover provided by this insurance is subject to the terms, conditions and exclusions of the Policy.
